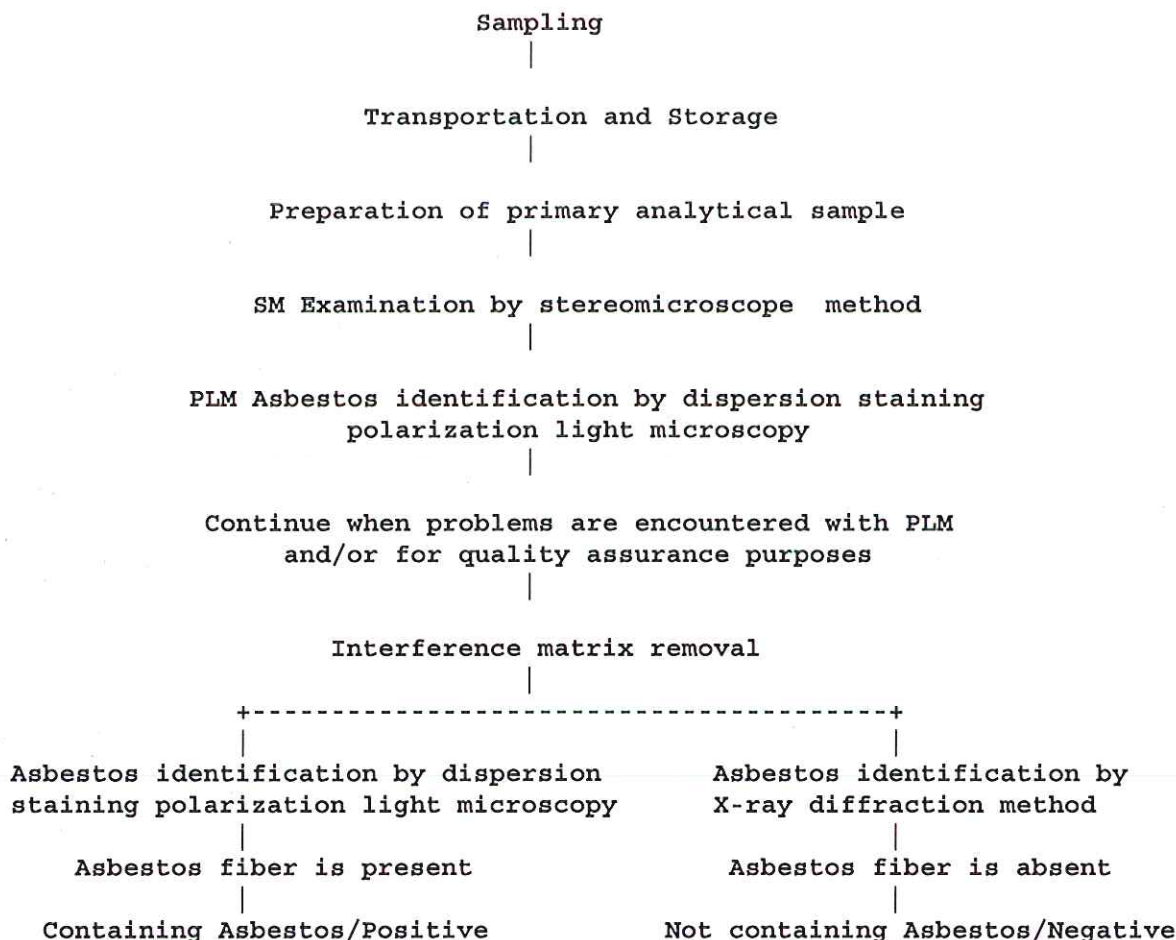

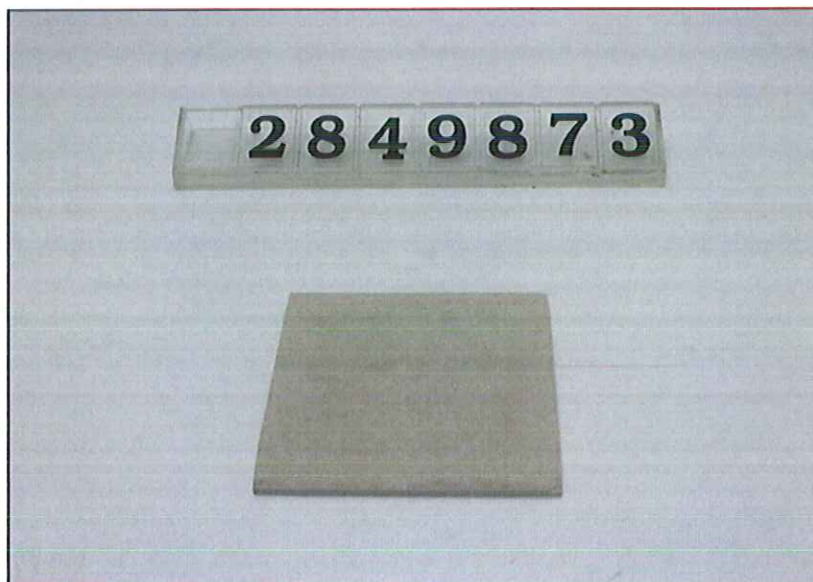
Analysis flow chart for determination of Asbestos
